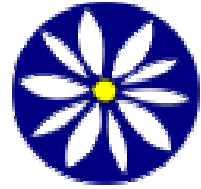

Dear Friend

Thank you for your enquiry about sponsored Tandem skydiving at Old Buckenham airfield, Norfolk. We appreciate your interest in helping to raise much needed funds for the Trust.

Founded in 1974 as the first Register of volunteers willing to donate bone marrow in circumstances where a match cannot be found within a patient's family, The Anthony Nolan Trust now holds one of the largest databases of unrelated donors in the world.

Today, The Trust's laboratory staff can test some 500 blood samples a week from potential donors wishing to join the Register and the Trust has direct links with 60 other registers around the world. We have come a long way since those early days, and now the Register stands at around 319,000 and more than 300 donors are provided for patients every year. We continually need donors to help patients suffering from diseases which can only be helped by a bone marrow transplant.

The Anthony Nolan Trust relies on the generosity of the public to fund its life-saving work. We receive no government funding, and the lives of the thousands who turn to us for help every year can only be saved by voluntary donation. Every £50 raised by the Charity enables us to add one new volunteer, fully tissue-typed, to the Register. That's one more life that just might be saved by your generosity.

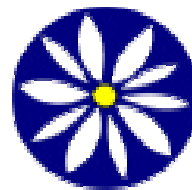

AGREEMENT FOR SPONSORED 10,000ft TANDEM SKYDIVE

I, the undersigned, agree to pay the minimum of £360 (raised in sponsorship and donations) as follows:

Four cheques, backed by a cheque guarantee card and made payable to **The Anthony Nolan Trust**:

- One for £60 payable on booking a date for your jump, (This is non-refundable in the event of you subsequently cancelling your booking) – and, on the day of your jump:

- One for £100 post-dated 14 days after the jump.
